# 1.0 Overview of SEWP V

The principal purpose of NASA's Solutions for Enterprise-Wide Procurement (SEWP) V contracts is to provide state-of-the-art information technology and computer technologies, high-end scientific and engineering processing capabilities, network equipment and peripherals. These Government-Wide Acquisition Contracts (GWACs) are available for ordering by all NASA centers, all federal agencies and their contractors. NASA's Goddard Space Flight Center, Greenbelt, Maryland procures and manages the SEWP V effort.

The SEWP V contracts are commercial-based contracts, whose acquisition ensued using formal Source Evaluation Board (SEB) procedures. The SEWP V solicitation comprised one set of terms and conditions, one set of proposal instructions and evaluation criteria, and multiple sets of specifications for Information Technology (IT) developed around core competencies of state-of-the-art IT products.

Effective May 1, 2015, DLT Solutions will provide a wide variety of technology solutions under Group A (NGG15SC07B) and Group D (NGG15SC32B) of the NASA Solutions for Enterprise-Wide Procurement (SEWP V) Contracts.

All the awards are for firm-fixed-price, indefinite-delivery/indefinite-quantity contracts (IDIQs). Each contract will have an effective ordering period of 10 years, consisting of a five-year base period from May 1, 2015 to April 30, 2020, and one five-year option period from May 1, 2020 to April 30, 2025.

However, as part of multi-award contract groups A and D, Fair Opportunity must be provided to all other contract holders in those groups.
