WHAT IS COVERED UNDER THIS AGREEMENT?

The Symantec Enterprise Software Licensing (ESL) Agreement consists of two parts:

1. **ELA** — Covers new license purchases for products within the Endpoint Encryption Suite, as well as maintenance renewals for all existing licenses. All products on the ELA are covered under an approved Class Limited Source Justification (CLSJ).
