End User License Agreement for Progress MOVEit Client

(Last Updated May 8, 2020)

IMPORTANT – PLEASE READ THIS END USER LICENSE AGREEMENT (THE "AGREEMENT") CAREFULLY BEFORE ATTEMPTING TO DOWNLOAD OR USE ANY SOFTWARE, DOCUMENTATION, OR OTHER MATERIALS MADE AVAILABLE BY PROGRESS SOFTWARE CORPORATION THROUGH THIS REPOSITORY. THIS AGREEMENT CONSTITUTES A LEGALLY BINDING AGREEMENT BETWEEN YOU OR THE COMPANY WHICH YOU REPRESENT AND ARE AUTHORIZED TO BIND (the "Licensee" or "You"), AND PROGRESS SOFTWARE CORPORATION ("Progress" or "Licensor"). BY DOWNLOADING, INSTALLING, OR OTHERWISE USING THE SOFTWARE (AS DEFINED BELOW) YOU ACKNOWLEDGE (1) THAT YOU HAVE READ THIS AGREEMENT, (2) THAT YOU UNDERSTAND IT, (3) THAT YOU AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS, AND (4) TO THE EXTENT YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF A COMPANY, YOU HAVE THE POWER AND AUTHORITY TO BIND THAT COMPANY.

1. Software License

- 1.1 License Grant. Subject to the terms and conditions set forth in this Agreement, Progress hereby grants to Licensee and Licensee hereby accepts, a limited, non-transferable, perpetual, non-exclusive license (the "License") to install and use, in object code form only, the Progress computer software identified as Progress MOVEit Client and any updates, upgrades, modifications and error corrections thereto provided to Licensee (the "Programs") and any accompanying documentation (the "Documentation", together with the Programs, collectively the "Software") solely as specified in this Agreement.
- 1.2 Scope of Use. You may use the Software solely for your personal or internal business purposes.



- 1.3.1 Except as required by law notwithstanding contractual prohibition, You are not allowed to disassemble, decompile or "unlock", decode or otherwise reverse translate or engineer, or attempt in any manner to reconstruct or discover any source code or underlying algorithms of the Software.
- 1.3.2 You are not allowed to resell, transfer, rent, lease, or sublicense the Software or Your associated rights.
- 1.3.3 You are not allowed to copy, modify, merge, or distribute copies of the Software or any portion thereof.
- 1.3.4 You are not allowed to use the Software: in any manner which violates national, federal, state, and/or local laws, rules, and regulations including, without limitation, those laws and regulations relating to data privacy and security; or, in any manner which violates the rights of Progress or any third party.

2. Term and Termination

This Agreement and the License granted hereunder shall continue for as long as You use the Software in compliance with the terms herein and shall automatically self-terminate upon Your noncompliance with the terms of this Agreement. Upon such termination, You must immediately cease use of the Software and destroy all copies of the Software in Your possession

3. Intellectual Property

3.1 All title and ownership rights in and to the Software and content (including but not limited to any images, photographs, animations, video, audio, music, or text embedded in the Software), the intellectual property embodied in the Software and content, and any trademarks or service marks of Progress that are used in connection with the Software and/or content are and shall at all times remain exclusively owned by Progress and its licensors. All title and intellectual property rights in and to



the content that may be accessed through use of the Software is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This Agreement grants You no rights to use or redistribute such content.

3.2 The Software may contain or be accompanied by certain third party components which are subject to additional restrictions. These components, if any, are identified in, and subject to, special license terms and conditions set forth in the "readme.txt" file, the "notices.txt" file, or the "Third Party Software" file accompanying the Software ("Special Notices"). The Special Notices include important licensing and warranty information and disclaimers. In the event of a conflict between the Special Notices and the other portions of this Agreement, the Special Notices will take precedence (but solely with respect to the third party component(s) to which the Special Notice relates). Unless otherwise addressed in the Special Notices, any open source software that may be delivered by Progress embedded in or in association with Progress products is provided pursuant to the open source license applicable to the software and subject to the disclaimers and limitations on liability set forth in such license.

4. Collection and Use of Data.

Progress uses tools to deliver certain Software features and extensions, identify trends and bugs, collect activation information, usage statistics and track other data related to Your use of the Software as further described in the most current version of Progress's Privacy Policy (located at: https://www.progress.com/legal/privacy-policy). By Your acceptance of the terms of this Agreement and/or use of the Software, You authorize the collection, use and disclosure of this data for the purposes provided for in this Agreement and/or the Privacy Policy.

5. No Warranty

THE SOFTWARE IS LICENSED 'AS IS'. YOU BEAR THE RISK OF USING IT. PROGRESS GIVES NO EXPRESS WARRANTIES, GUARANTEES OR CONDITIONS. YOU MAY HAVE ADDITIONAL RIGHTS UNDER YOUR LOCAL LAWS WHICH THIS AGREEMEN CANNOT CHANGE. TO THE EXTENT PERMITTED UNDER YOUR LOCAL LAWS, PROGRESS EXCLUDES THE IMPLIED WARRANTIES OF TITLE, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

If any dispute, controversy, or claim cannot be resolved by a good faith discussion between the parties, then it shall be submitted for resolution to a state or Federal court of competent jurisdiction in Boston.

11. Survival

Any provisions of the Agreement containing license restrictions, including but not limited to those related to the Program source code, warranties and warranty disclaimers, limitations of liability and/or indemnity terms, and any provision of the Agreement which, by its nature, is intended to survive shall remain in effect following any termination or expiration of the Agreement.

12. Severability

If a particular provision of this Agreement is terminated or held by a court of competent jurisdiction to be invalid, illegal, or unenforceable, this Agreement shall remain in full force and effect as to the remaining provisions.

13. Export Classifications

You expressly agree not to export or re-export the Progress Software to any country, person, entity or end user subject to U.S. export restrictions.
