# **TD SYNNEX Public Sector's Contract Access Agreement**

- What is it? TD SYNNEX Public Sector's contract access agreement gives TD SYNNEX Public Sector's channel partners access to all of TD SYNNEX Public Sector's in house prime contract vehicles. CAA is similar to a finders fee program, however the channel partner is able to recognize top line revenue through the exchange
- Who can use it? Any onboarded TD SYNNEX Public Sector Partners with active CAA
- What contracts can it be used on? 80+ contract vehicles
- **Benefits?** Provides flexible buying options to end user customers, enables channel involvement even when contract does not permit Participating Dealers, allows end user customer to maintain relationship with previous channel partners, minimal paperwork to establish CAA between TD SYNNEX Public Sector and channel partner

#### **Quoting Process**

- Step 1 Partner reaches out to TD SYNNEX Public Sector with opportunity
- Step 2 TD SYNNEX Public Sector contacts OEM for cost quote
- Step 3 TD SYNNEX Public Sector quotes the channel partner
- Step 4 Partner quotes TD SYNNEX Public Sector with their pricing up lift, while still quoting under contract ceiling
- **Step 5** TD SYNNEX Public Sector flips quote back onto TD SYNNEX Public Sector paper and quotes the end user customer the full price including channel partner's uplift

#### Order Award and Purchase Order Processing:

- Step 1 End user customer awards order to TD SYNNEX Public Sector via purchase order
- Step 2 TD SYNNEX Public Sector issues a purchase order to the channel partner for the full award amount
- Step 3 Partner places order with TD SYNNEX Public Sector based on TD SYNNEX Public Sector's quote
- Step 4 TD SYNNEX Public Sector places order with OEM

#### Invoicing:

- **Step 1** OEM invoices TD SYNNEX Public Sector for full order
- Step 2 TD SYNNEX Public Sector invoices channel partner at their quoted cost
- Step 3 Partner invoices TD SYNNEX Public Sector the full cost to end user customer
- Step 4 TD SYNNEX Public Sector invoices end user customer for full order amount

#### **Customer Payment:**

- Step 1 TD SYNNEX Public Sector collects full order payment from end user customer
- Step 2 TD SYNNEX Public Sector nets out payment to channel partner \*\*(TD SYNNEX Public Sector and channel partner pay each other simultaneously to satisfy invoicing) \*\*
- Step 3 TD SYNNEX Public Sector pays OEM

#### **Important Reminders:**

- All end user customer facing documents will be on TD SYNNEX Public Sector paper
- No credit card orders
- Orders must be over \$25K
- Services cannot be included on orders
- No incremental funding/billing (i.e. Cloud)
- No lease/finance deals

TD SYNNEX Public Sector does not hold any contract vehicles. The names of the legal entities that hold various federal and state contracting vehicles - DLT Solutions, LLC, Tech Data Government Solutions, LLC and TD Synnex Corporation - will remain the same at this time and will continue to operate under their respective contracting vehicles.
