The Need

Increased Efficiency for Revenue Collection

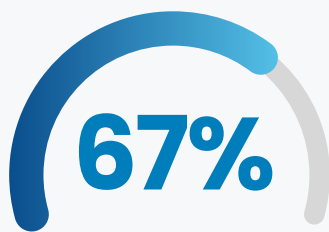

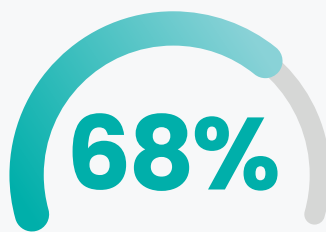
Leveraging a short-term rental solution can become the force multiplier that agencies desperately need, as software helps to automate these processes, significantly improving revenue collection efficiency.

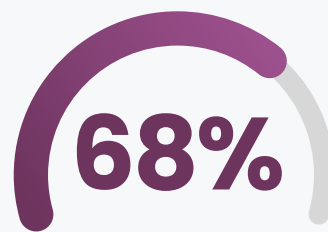

Simplified Compliance for STR Operators

Staying in compliance with government regulations can be overwhelming for individuals, many of whom report not understanding tax codes.

The Need

The County's Tourist Development Tax amounts to **more than \$30 million in annual revenue**. Although the County already had an online tax solution in place, the software vendor was not meeting their needs. They needed a solution that could not only manage tax collections efficiently but also improve the taxpayer experience and provide better data reporting.

The Solution

After researching vendors, the County selected the GovOS STR compliance, registration, and tax collection solutions. Staff took to the system quickly, using it to issue notifications to tax customers, identify non-compliant STR properties, and leverage the system's extensive reporting capabilities.

The Results

Currently, the County has less than half a percent of delinquent accounts remaining, and **98% of all transactions are paid online**. Using the GovOS system, Okaloosa County collected more than \$76,500 in penalties and interest and reported a **\$1 million increase in funds** distributed to municipalities compared to the previous year.
