# The Big Picture – and the Big Costs – of Not Changing

Legacy systems drain government agencies with rising costs and declining efficiency. The results below are based on analysis of transaction data before adopting GovOS.



#### Less Revenue

20% less when staff don't have the ability to focus on adoption and compliance because they are too tied up in day-to-day work.
