




Diagram: eSignature & DTM on Blockchain

Ensure your documents were not tampered with, revised, revoked or cancelled.


4n6 (FORENSICS) TOKEN

ZorroSign uses permissions-based private Blockchain technology to ensure the security and privacy of the users' information (who are part of a transaction), the data and also to ensure the sanctity of digitally signed documents using RSA encryption. ZorroSign detects tampering and signature forgery of electronically signed documents through its proprietary software and patent pending 4n6 (Forensics) Token. It provides chain of custody, full audit trail, and a number of additional attributes and characteristics about a document.

The document owner can assign permissions such as view, validate and deny access to the main document and its attachments. 4n6 (Forensics) Token is the multipurpose bridge which can comprehensively validate both electronic and paper documents. When challenged or investigated it can be used as evidence without repudiation in a court of law.

4n6 (Forensics) Tokens cannot be altered, pasted or forged onto another document. If a deliberate act is carried out, the 4n6 Token when read will show the original intended valid document.


